

**Hi Rise Ski Club**  
**Trip Application & Agreement**

2017

The undersigned participant applies to participate in the Hi Rise Ski Club (Hi Rise) trip described below, subject to the following terms and conditions:

1. Deposits: Advance trip deposits will vary from trip to trip. The required deposit for this trip is \$100 and must be paid and submitted along with a signed Application and Agreement. Balance shall be due and payable in accordance with payment schedules established by Hi Rise. Final payment is due in full not less than 10 days prior to departure in the case of weekend trips and not less than 45 days prior to departure in the case of longer trips. The final payment due date may be longer in some trips. Hi Rise may add supplemental costs such as fuel taxes and airport departure charges to the price of this trip.
2. Withdrawal and Change: Hi Rise may withdraw any trip from its schedule at any time; may refuse to accept or retain any person as a participant at any time for any reason; and may change the itinerary at any time.
3. Responsibility: Hi Rise is acting gratuitously for the applicant and shall not be responsible or liable for any loss of or damage to baggage, property, or for any loss, injury, death, accident, delay, inconvenience or any other loss occurring during or occasioned by applicant's participation in any trip, and as a result of any actual or alleged negligence of Hi Rise or any Hi Rise member or officer.
3. **Passports/Proof of Citizenship: For trips out of the USA, participants are responsible for having up to date and valid passports, visas and proof of identification and citizenship. For all trips involving air travel, participant is responsible for having identification acceptable to the air carriers.**
4. Minors: Any minor's participant's Application & Agreement must be co-signed by his/her parent or legal guardian. The minor must be accompanied on the trip by a parent or legal guardian or their designee who shall be wholly and fully responsible for said minor's conduct and well being.
5. Payment: All payment checks shall be payable to "**Hi Rise Ski Club**".
6. Cancellation & Refunds:
  - A) Cancellation by participant means and includes: failure to abide by the terms of this agreement, notice by participant of intent to cancel; participant's failure to make timely payments; participant's failure for any reason to meet the departure or return of the trip.
  - B) Where Hi Rise cancels or withdraws a trip the participant shall be entitled to a full refund unless such cancellation or withdrawal is necessitated or caused, in whole or part, by participant's cancellation or failure to make timely payments.
  - C) Where participant cancels more than 30 days before the departure of a weekend trip or more than 60 days before the departure of a longer trip, then participant shall be responsible for a cancellation service charge of not less than \$10.00.
  - D) In addition, where participant cancels less than 30 days before the departure of a weekend trip or less than 60 days before the departure of a longer trip and where the trip departs full or where participant provides an immediate replacement who completes this agreement then participant shall receive a full refund less the cancellation service charge. However, if the trip departs less than full and participant has not provided a replacement, then participant may be entitled to a partial refund less any amounts paid by Hi Rise for participant's unused transportation, lodging, meals, lifts, or amenities and less the cancellation service charge. In any case the participant is responsible to Hi Rise for any amounts paid out by Hi Rise over and above payments made by participant. Hi Rise may modify or change balance due dates and cancellation deadlines to accommodate its payments to airlines, lodges, bus companies, and travel agents.
8. Eligibility: Participation in this trip is available first to Hi Rise Ski Club Members, and to the member of any organization that Co-sponsors this trip with Hi Rise, and their families. Any non-members must pay an additional charge TBA.
